Dear Parents/Guardians:

All 6th grade students must show proof of TDAP vaccination BEFORE being allowed to attend 7th grade at the middle school in the 2016-2017 school year. This includes summer school.

Your registration in summer school is at risk if you have not yet submitted your Tdap vaccine record. Please submit your Tdap records to your 6th grade health office as soon as possible. Students who do not have these records on file will not be allowed to attend school until it has been submitted.

Whooping cough (pertussis) has been widespread in California during 2010. The California Department of Public Health recommends that all Californians 10 years and older receive a booster shot against pertusis (also known as "Tdap"). Moreover, **Assembly Bill 354 requires** students in Grade 7 to be immunized against pertussis.

The following outlines the requirements of this law:

- If a child has received one dose of Tdap vaccine after the age of 7, the requirement is met. Please submit proof of vaccination to the health clerk at your child's current school to ensure compliance.
- It applies to all public and private schools.

Adults are also advised to get a pertussis booster shot, if they haven't already, to protect themselves, their families, and their students.

HEALTH ALERT

All students in 6th grade must show proof of Tdap vaccination before receiving 7th grade registration materials in Spring 2016. Students may begin submitting proof of Tdap to their school's health office now.
