Questions from audience:

Q1: Will this presentation be available on our website?

A1: Yes, If you go to our District website and go to our department/ LCAP, it will give you all of our presentations for the year. You will also see the powerpoint of this presentation.

Q2: What was the goal of this meeting?

A2: The goal of this meeting is to give an overview of the LCAP – where we are and where we are going. GUSD wanted to get the information out to all in the community and get feedback and answer any questions prior to the public hearing on June 6. GUSD wants to create a database of community members who may be interested in joining our LCAP group next year so please make sure you signed in and included your email address. GUSD continues to look at engagement of the LCAP and ways to strengthen that piece.

Q3: When will the LCAP Advisory Meeting actually happen?

A3: This is the second of three parent advisory meetings scheduled prior to the public hearing on June 6 (May 3, 18, 22). GUSD has had six or seven LCAP meetings held at the District office, which included parents, teachers, administrators, staff, students and community members. This LCAP stakeholder group has advised the LCAP process for the past four years in providing input and suggestions in the development of the LCAP. Per the LCAP regulations and a request from parents this year to create a separate opportunity for parent input, these cluster parent meetings were scheduled to present the proposed LCAP, get input and answer any questions. GUSD considers these three meetings as our parent advisory meetings and moving forward will evaluate how parent input is provided and explore ways to strengthen parent engagement.

Q4: Will you have additional meetings to allow parents to provide questions that the Superintendent will then be able to respond to in writing.

A4: GUSD believes they have met that requirement through the seven stakeholder meetings to review and develop the LCAP – and GUSD has already had two community meetings and will have another one with DELAC on the 22nd, as well as the public hearing on June 6, 2017. All questions asked at those three meetings will be answered and posted on the GUSD website for review. GUSD takes pride in answering all questions posed around the improvement of student achievement and parent engagement. The GUSD website is a good resource for all information around the development of the LCAP and Dr. Rinder's information is posted should there be any additional questions.

Q5: When will the 2016-2017 information be available.

A5: This information was presented in the seven LCAP meetings held this year at the District office to review and develop the LCAP. At the parent advisory meetings a brief review of the LCAP process, annual update, (always a year behind in data), which states what GUSD set out to do, what GUSD did, and through the analysis suggested changes in future LCAPs goals, actions and services. GUSD believes the LCAP process should be collaborative. There will be a public hearing on June 6, 2017 at 6:30pm in the board room and you can definitely provide further input and feedback at that time. If we need another meeting to look at the LCAP, GUSD will be happy to hold it.
