"This is an engaging and interactive educational presentation utilizing friendly competition and lively retelling of common core history curriculum; **"Walk Through California"** for fourth grade, **"Walk Through the American Revolution"** for fifth grade, and **"Walk Through the Ancient World"** for sixth grade. The presentation is facilitated by an animated and trained presenter who guides up to 36 students through historical events using dynamic, kid-friendly stories and activities. Throughout the presentation games, music, and dramatic activities encourage participation and comprehension of the curriculum.

These Walk Through experiences are a great way to integrate the arts, specifically drama, with core content. They also develop students listening and speaking skills, and the presentations are very interactive and highly engaging. California Weekly provides teachers with all the necessary materials to prepare students for their presentation. Additionally, in 5th and 6th grade, students have small acting parts where they take on the role of a key person from that time period.
